WHEREAS, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 12:00 Noon, on Thursday, July 28, 2016, for the purchase of three 2016 all-wheel drive Dodge Charger Police Pursuit Vehicles (PPV'S) and seventeen 2016 rear-wheel drive Dodge Charger PPV's at the request of the Forsyth County General Services Department and intended for use by the Forsyth County Sheriff's Department and the following bids were received:

WHEREAS, it is the recommendation of the County Manager, the County General Services Director, and the City/County Purchasing Director that a contract for the purchase of three 2016 all-wheel drive Dodge Charger PPV's in the amount of \$76,782 and seventeen 2016 rear-wheel drive Dodge Charger PPV's in the amount of \$412,352 be awarded to Performance Chrysler Dodge Jeep Ram for a total amount of \$489,134; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of these contracts.

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners, that a contract for the purchase of three 2016 all-wheel drive Dodge Charger PPV's in the amount of \$76,782 and seventeen 2016 rear-wheel drive Dodge Charger PPV's in the amount of \$412,352 is hereby awarded to Performance Chrysler Dodge Jeep Ram in the total amount of \$489,134 and that all other bids are hereby rejected.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Performance Chrysler Dodge Jeep Ram for the purchase of three 2016 all-wheel drive Dodge Charger PPV's and seventeen 2016 rear-wheel drive Dodge Charger PPV's consistent with the terms outlined herein, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
