

**ORDINANCE NAMING AN UNNAMED ROAD SEGMENT LOCATED OFF
CAMP BETTY HASTINGS ROAD WITHIN THE UNINCORPORATED AREA
OF FORSYTH COUNTY, CONIFER ROAD
(MAPFORSYTH ADDRESSING TEAM)**

WHEREAS MapForsyth staff requested the naming of an unnamed road segment located off Camp Betty Hastings Road within the unincorporated area of Forsyth County, Conifer Road;

WHEREAS the Addressing Team of MapForsyth received no opposition in the proposed road name from the adjoining property owners;

WHEREAS the proposed road name does not pose any address range or road name duplication issues; and

WHEREAS pursuant to the provisions of N.C.G.S. 153A-239.1, at least ten (10) days prior to conducting the public hearing to name the said road segment, Forsyth County caused notice of the time, place, and subject matter of the hearing on this proposed road naming to be prominently posted at the Forsyth County Courthouse and in at least two public places in the township where the road is located, and to be published in a newspaper of general circulation in Forsyth County;

NOW, THEREFORE, BE IT ORDAINED, by the Forsyth County Board of Commissioners, after providing notice and conducting a public hearing as required by law, that the road segment located off Camp Betty Hastings Road within the unincorporated area of Forsyth County, as further identified on the attached map, is hereby named Conifer Road.

BE IT FURTHER ORDAINED, that after naming Conifer Road, Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the N.C. Board of Transportation, and to any municipality within five miles of the said road as required by law; and

BE IT FURTHER ORDAINED, that this Ordinance shall become effective upon its adoption.

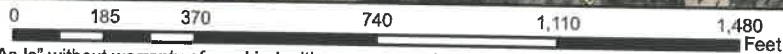

Notice is hereby given that Forsyth County will conduct a public hearing on Thursday, September 12, 2019, at 2:00 p.m. in the Forsyth County Commissioners' Meeting Room on the Fifth Floor of the Forsyth County Government Center located at 201 N. Chestnut Street, Winston-Salem, N.C., pursuant to the provisions of N.C.G.S. 153A-239.1 on the following proposed ordinance:

To name an unnamed road segment located off Camp Betty Hastings Road within the unincorporated area of Forsyth County, Conifer Road

This notice shall be published once at least ten (10) days before the public hearing date in a newspaper of general circulation in Forsyth County, and prominently posted at the County Courthouse and in at least two public places in the township nearest the road location.
