SUMMARY OF INFORMATION:

The Forsyth County Department of Public Health requests authorization to submit an application to the Kate B. Reynolds Charitable Trust for a grant of \$350,000 per year for three fiscal years, representing a total of \$1,050,000, beginning in FY 15, to support the continued operation of the Cleveland Avenue Dental Clinic operated by the Department of Public Health.

The grant funds will be used to offset County expenditures for the Dental Clinic operations, build staff capacity, and expand dental services. Through the implementation of a three year growth and sustainability plan, the goal of the grant for the Dental Clinic is to improve access to dental care and enhance oral health outcomes for eligible Forsyth County residents of all ages.

BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the submission of an application to the Kate B. Reynolds Charitable Trust for a grant in the amount of \$350,000 per year for three years representing a total of \$1,050,000 to support the implementation of a growth and sustainability plan for the continued operation of the Cleveland Avenue Dental Clinic to serve eligible Forsyth County residents of all ages.

BE IT FURTHER RESOLVED by the Forsyth County Board of Commissioners that the Chairman or County Manager and the Clerk to the Board are hereby authorized to execute the necessary documents, on behalf of Forsyth County and its Department of Public Health, to submit an application for grant funds to the Kate B. Reynolds Charitable Trust as provided herein, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
